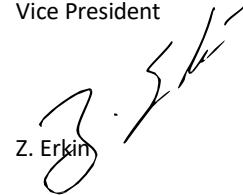

3. Annual plan 2023

ACCSS Annual Plan 2023

Introduction

The years 2021 and 2022 were mainly devoted to building up the association, membership recruitment and setting up the organization (ref. Annual Plan 2021-2022, 22-ACCSS-038). During 2022, ACCSS continued to grow and gained a visible position in the Dutch cybersecurity playing field. It is now important to steadily build on the organization and expand its activities.

The association will enter the new year with a changed board and a new set-up of operations. One of the directors is leaving the association due to retirement. With the completion of the organization of the association and the establishment of the business operations around it, the agreement with the current director of operations will end.

A key challenge in 2023 is ensuring the continuity of the association, both administratively and corporately.

Elements Annual Plan 2023

The structure of this annual or activity plan corresponds in part to the structure of the 2021-2025 policy plan, namely an elaboration of the association's three core objectives of Networking, Gateway and Policy Advocacy.

In addition, we elaborate below on three new elements: New Ambitions, Internal Organization, and Delegations.

A. Networking function

- Participate in the national cyber exercise ISIDOOR 2023 with an ACCSS team (explanation in 22-ACCSS-082b)
- (Contribute to the) organization of events (for our members, but also showcases and matchmaking events) independently or (preferably) in collaboration with partner organizations. For example, involvement of ACCSS or related organizations in ICT.Open, the annual ICT conference of NWO and IPN, which also focuses on cybersecurity research, and involvement in FUSION. In 2023 there will be editions of both ICT.Open (in April) and FUSION (in May, June). With FUSION, collaboration with INTERSECT and NWO will again be pursued. Contributions to dcypher events or parts of the central government are also included
- Organize the (annual) Dutch cybersecurity best research paper (DCSRP) award competition and ceremony with the SIG-CS (as part of FUSION 2023)
- (Further) develop, position and support existing and new ACCSS member work groups
- Provide support for workshops and/or meetings to be organized by ACCSS working groups

B. Gateway

- Ensure proper visibility, profiling, branding and marketing of ACCSS (association of, by and for scientists)
- Maintain contacts with the other links in the knowledge chain, governments, private partners, and media
- Direct questions and requests to appropriate members

C. Policy Advocacy

- Primarily organize the input from the academic community and function as a voice on behalf of that community
- Pursue involvement of ACCSS members in policy development, strategy and policy implementation initiatives (large and small) and, where useful, involvement in oversight from the central and/or local government
- Represent ACCSS interests within the central government

D. New ambitions

- Write agenda, manifest or exploration on cybersecurity research in the Netherlands, as a follow-up to the NCSRA-III (from 2018) and with a link to the NLCS 2022-2028 (and as inspiration for cybersecurity calls NL4CS)

Examples:

- a) slide deck "obviously safe" (ref. 22-ACCSS-013)
 - b) software engineering exploration (ref. 22i-ACCSS-047)
 - c) Future Computer Systems and Networking Research in the Netherlands: A Manifesto (ref. 22i-ACCSS-035)
- Develop vision for cybersecurity innovation based on the idea that many innovations have their origins in academia, which is, therefore, an important part of the innovation chain
 - Conduct inventory of cybersecurity (higher) education in the Netherlands (education work group)
 - Conduct inventory of sister organizations of ACCSS abroad (see SIDN evaluation report)

E. Internal organization

- Strengthen internal organization
- Appoint a new director of operations
- Conduct inventory of support tasks and adjust support apparatus as needed
- Expand the board and develop plans for consolidation of the association's administration and sustainability
- Establish a communications work group and develop a communications plan for ACCSS (website, social media, newsletter)
- Pursue greater ACCSS meeting efficiency: optimal synergy, an efficient ratio of physical and online settings, and meeting colocation will be priorities when planning the annual meeting agenda (ref. ACCSS Meeting Annual Agenda 2022 and 2023)
- Implement the donation/sponsor policy (in addition to SIDN, also with SURF Foundation?), given the ANBI status obtained as of January 1, 2022 (retroactively).
